## Rokka Ski School & Rokka Ski Club Release of Liability and Indemnification

- 2. I accept my responsibility to ski safely at all times, to abide by the Skier Responsibility Code, and to obey all posted behavior notices and any other ski area rules and policies. Any equipment I use while skiing, I use at my own risk.
- 3. I agree that I will not sue or make a claim against Rokka Ski School, Rokka Ski Club, Rokka Ski Lodge, Boyne USA Inc., or any of its owners, officers, agents, or subsidiaries, including but not limited to, Ski Lifts Inc., Crystal Mountain, Inc., Alterra Mountain Company; and the U. S. Government or any of (their/its) employees, agents contractors, subsidiaries, officers ("Released Parties") for any loss, injury or damage resulting from any cause including negligence, which arises out of my participation in any activity at the ski area, including but not limited to, use of the slopes, equipment, or any of the facilities or services on the premises.
